



2011 Association of Boards **UPDATE!** of Certification (ABC)


he Canadian Validation and Examination Committee met in Toronto this October to update the Operator Certification Exams in Wastewater Treatment and Collection and Water Treatment and Distribution. The committee meets every two years to update and improve the ABC Canadian Standardized Certification Exams. The committee goes through guestions in the exam database and selects the exam questions for the new standardized exams. Questions that are misleading, poorly written, or have poor references to study material are removed and sent back to another committee to be re-written and updated. Operators, managers, and regulators from across the country take part in these discussions and workshops to ensure that all facets of operation and certification are covered. Taking part in this year's meeting representing Operators from British Columbia were John Reynolds and Brian Thorburn.

ABC Biosolids Land Appliers, and Plant Maintenance Technologist Certification

Operators, did you know that the Association of Board of Certification have a certification program for biosolids land appliers and for plant maintenance staff. 

Certification Exam Security and Candidate Identification

The EOCP will be further increasing exam security and implementing full candidate identification in 2012. Like many other Operator Certification agencies, the EOCP has decided that photo identification will be required in order to write any EOCP exam. Approved picture identification will include: drivers' licenses. passports, or provincial or federal picture ID. Please be prepared to show your ID as you will not receive an exam without it. As well, a number of Operators have wanted to use their cell phones as calculators during examinations; this will be absolutely forbidden. BC and elsewhere have experienced Operators trying to use their cell phones to photograph exams. In order to keep the certification exams secure, all phones must be turned off during the exams and put away. No cell phones will be allowed on the examination table.
